Incase the Institution could not commence the above mentioned courses for whatsoever reasons during the two years period from the date of issue of this letter, the approval becomes invalid and the applicant society/trust shall have to make fresh application to AICTE for grant of fresh approval.

- 6. That the accounts of the institution shall be audited annually by a certified chartered accountant and so open for inspection by the Council or any body or persons authorized by it.


